- ✓ Applicants must have a GPA of 2.85 or better

### 1. Application requirements:

- ✓ A complete and signed application
- ✓ One letter of recommendation from a school official (administrator, teacher, or counselor)
- ✓ One letter of recommendation from a person not associated with your school and not a family member; **preferred sources are from your church, a community organization, a previous teacher, or a counselor.**
- ✓ A copy of an official transcript indicating mandatory 2.85 GPA or better

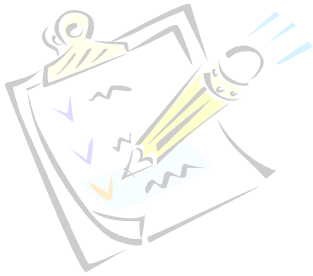

**Debutante Program Frequently Asked Questions**

- ***What is the participation fee for the Ladies in Waiting Program?***

The overall cost for Ladies-in-Waiting is \$950. This cost includes a participation fee of \$750, and a required minimum of \$200 in ad sales.

- ***What is the participation fee for the Debutante Program?***

The overall cost for Debutantes is \$2280. This cost includes participation fee of \$1100, \$180 escort fee, and a required minimum of \$1000 in ad sales.

- ***When is my deposit expected to be paid?***

Debutantes and Ladies-in-Waiting are expected to submit a \$200 non-refundable deposit at the Welcome Reception scheduled for May 2010.

- ***What are the acceptable forms of payment for my participation fee and ad sales?***

Credit cards, cashiers checks, and money orders made out to SM-LAC are the ONLY acceptable forms of payment for fees and ad sales. Personal checks are not accepted.

- ***Where are the workshops and events held?***

The majority of activities and workshops sponsored by the SM-LAC Debutante Committee will take place in Dekalb County in the Stone Mountain-Lithonia area. However, there are a few activities that could potentially be in other counties in the metro area. Transportation to and from these events is the sole responsibility of the parent/sponsor.

- ***What are my obligations as a parent?***

Primarily, we need parents to ensure that their child attends all of the scheduled activities and that she is committed to all of the expectations defined in the program. Parents should assist their daughter with ad solicitation. They should also be in attendance at the two scheduled parent meetings (one scheduled in the fall and one schedule in the spring).
